1. The grant for recognition is not extendable and does not in any way imply any obligation to recognize/affiliate beyond Class VIII
2. The school shall abide by the previous of right of children to free and compulsory education Act, 2009 and the Right of Children to Free and Compulsory Education rules, 2009
3. The School shall admit in class I, to the extent of 25% of the strength of that class, children belonging to the weaker section and disadvantage grouping the never hood and providing the free and compulsory elementary education till it is completion provided future in that case of pre primary classes also this norm shall be followed .
4. For the children refer to the paragraph 3 The school shall be reimbursed as per section 12 (2) of the act to receive such reimbursement school shall provide separate bank account .
5. The society school shall not collect any capitation fee and subject the child or his or her parents or guardian to any screening procedure.
6. The school shall not deny admission to any child for lack of age proof. if such admission is sought subsequent to the extended provided prescribed for admission. On the ground of religion, caste or raw, place of birth or any of them.
7. The school shall ensure
  - (a) No child admitted shall be held back in any class or expelled from school till the completion of elementary education in a school .
  - (b) No child shall be subjected to physical punishment or mental harassment.
  - (c) No child is required to pass any board examination till the completion of elementary education.
  - (d) Every child completing elementary education shall be awarded a certificate as laid down



- (e) Inclusion of student with disabilities /special need as per provision of the act.
- (f) The teachers are required with minimum qualification as laid under section 23 (1) of the act provided further that the current teacher who at the commencement of this act do not possess minimum qualification shall acquire such minimum qualification with in a period of 5 years.
- (g) The teacher performs its duties specified under section 24 (1) of the act and
- (h) The teachers shall not engage himself or herself for private teaching activities.
8. The school shall follow syllabus on the basis of curriculum laid down by appropriate authority.
9. The school shall enroll students proportionate to the facilities available in the school prescribed in the section 19 or the act.
